PERMIT FOR DISCHARGE OF ROAD HAULAGE DOMESTIC EFFLUENT AT A WASTE WATER TREATMENT WORKS (WWTW) IN TSHWANE

Your request of 02 February 2021 for the road haulage domestic effluent discharge permit refers.

The City of Tshwane is prepared to treat the road haulage domestic effluent from 02 February 2021. Your permit number will be **RHD093/2017**. This permit is valid for **(02 February 2021- 01 February 2022)** period and must be renewed by the expiry date.

This permit authorises Hire R Us to discharge only domestic sewerage at a WWTW of the City of Tshwane Municipality based on the City of Tshwane Sanitation By-laws **section 11** (*Acceptance of sewage delivered by road haulage*), **section 12(1) – (2)** (*Written permission for delivery of sewage by road haulage*), **section 13(a) & (b)** (*Conditions for delivery of sewage by road haulage*) and **section 14(a) & (b)** (*Withdrawal of permission for delivery of sewage by road haulage*). No discharge will be allowed at manholes or any other site. Violation of this clause will be punishable with a fine of R5000 and possible cleaning costs.

Infrastructure will be provided by the Municipality at their WWTW for the discharge of effluent, but it remains the responsibility of **Hire R Us** to clean the infrastructure after usage.

It is expected from Hire R Us to conform at all times with the requirements of section 31 (*storm water not to enter sewers*) **and section 32 (1) and (2)** (*sewage or other pollutants not to enter the storm water drains*) **of the City Tshwane Metropolitan Municipality as mentioned in the by-laws that states:-**

- 31 *No person may discharge or cause or permit to be discharged any substance other than sewage into a drainage installation.*
- 32 (1) *The owner or occupier of any piece of land on which steam or any liquid, other than potable water, is stored, processed or generated shall provide all facilities necessary to prevent any discharge, leakage or escape of such liquid to any street, storm water drain or watercourse, except where, in the case of steam, the Municipality has specifically permitted such a discharge.*
- (2) *Where the hosing down or flushing by rainwater of an open area on any private premises is, in the opinion of the Municipality, likely to cause the discharge of objectionable matter into any street gutter, storm water drain, river, stream or other watercourse, whether natural or artificial, or to contribute towards the pollution of any such watercourse, the Municipality may instruct the owner of the premises to execute, at his cost, whatever measures by way of alteration or the drainage installation or roofing of the area it may consider necessary to prevent or minimize such discharge or pollution.*

Toxic wastes, whether liquid or solid, may not be discharged at any WWTW, and must be discharged/disposed of at a recognised toxic waste treatment site.

Spot checks can take place at any time.

The following facilities (WWTW) may be used for applicable disposal:

- Daspoort (Pretoria)
- Sunderland Ridge (Centurion)
- Sandspruit (Soshanguve Ext-13)
- Temba (Hammanskraal)
- Rietgat (Soshanguve PP3)
- Zeekoegat (Roodeplaat)
- Rooiwal (Rooiwal)
- Rayton (Rayton)
- Rethabiseng (Rethabiseng)
